**Subject:-** Regarding combined inter-se-seniority list as it stood on 01-04-2010 of all the incumbents (Lecturers, Programmers, Sr. Lecturers & HOD) as Lecturers/Programmers and as Sr. Lecturers for the grant of PB-4: 37400-67000+8700

1. A 71<sup>st</sup> meeting of BOM was held on dated 19-01-2023 wherein the matter regarding combined Inter-se-seniority as it stood on 01-04-2010 of all the incumbents (Lecturers, Programmers, Sr. Lecturers & HOD) as Lecturers/Programmers and as Sr. Lecturers for the grant of PB-4: 37400-67000+8700 was put up vide Agenda Item No.71.5 under heading "To approve the combined tentative Inter-se-seniority list as it stood on 01-04-2010 of all the incumbents (Lecturers, Programmers, Sr. Lecturers & HOD) as Lecturers/Programmers and as Sr. Lecturers for the grant of PB-4: 37400-67000+8700 to 06 senior most incumbents @15% of the 39 sanctioned posts of Lecturers & Programmers after completion of 20-years of regular satisfactory service and to 01 senior most incumbents @15% of the 06 sanctioned posts of Senior Lecturers after completion of 14-years of regular satisfactory service and all HODs/TPO after completion of 07 years of regular satisfactory service in view of FD letter No.1/76/2011-1PR(FD) dated 18-10-2011, Rule-8(a) of ACP Rules-2008 & Rule-11 of Haryana Govt. Gaz. Notification Nov.13, 2001 (Departmental Service Rules of Group-B)."
2. The BOM in 71<sup>st</sup> meeting decided that "The House deliberated on the issue & the BOM members from the DGTE office, Panchkula made observations that any affected faculty should not be the member of the committee, so a fresh committee should be constituted & the Chairman BOM was authorised to constitute a committee to finalise the combined inter-se seniority list (as it stood on 01-04-2010) of all the Lecturers/Programmer, Sr. Lecturers & HODs for the grant of PB-4 after considering objections/grievances of the staff members. Thereafter the matter may be put up in the next BOM meeting."
